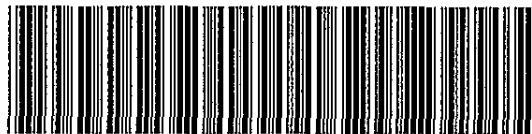




## **ARTICLE 9-TERMINATION OF EXISTENCE**
