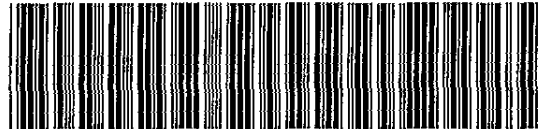

The business of the Company shall be managed by one or more members. The Company shall be a member-managed Company.


#### ARTICLE VI
