**ARTICLE I

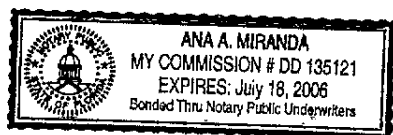

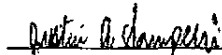
