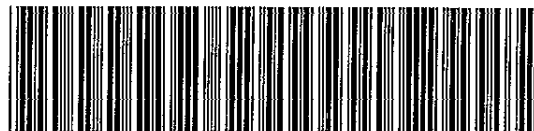

The mailing address and street address of the principal office of the Company shall be 1704 Floyd Street, Sarasota, FL 34239.


