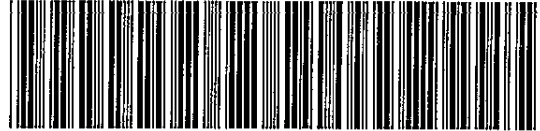



The mailing address and the street address of the principal office of the Company is 447 Kelsey Park Drive, Palm Beach Gardens, Florida 33410.


ARTICLE IV - INITIAL REGISTERED AGENT


