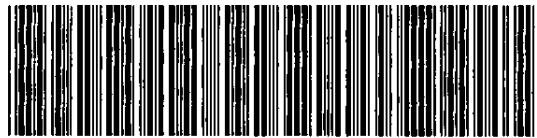



5. All the Members of the LLC consented to the Dissolution by signing a written Consent, dated November 16, 2009.


6. Adequate provision has been made for the debts, obligations, and liabilities of the LLC, pursuant to Section 608.4421, Florida Statutes.


