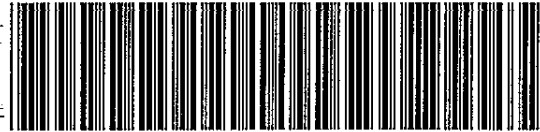

The undersigned, desiring to form a Limited Liability Company under and pursuant to §608.405, Florida Statutes, do hereby certify as follows:

FIRST: The name of said limited liability company shall be RENAL DOCS, LLC.

SECOND: RENAL DOCS, LLC shall exist in perpetuity.

THIRD: The principal office and the mailing address of RENAL DOCS, LLC shall be 2001 Medical Building, 2001 N.E. 48th Court, Fort Lauderdale, Florida 33308.

FOURTH: The purposes for which RENAL DOCS, LLC is formed are:

A. Engaging in any and all phases of the business of providing medical services.





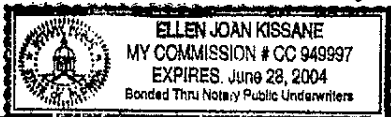
