ARTICLES OF ORGANIZATION

ARTICLE I - NAME

ARTICLE V - ADMISSION OF ADDITIONAL MEMBERS

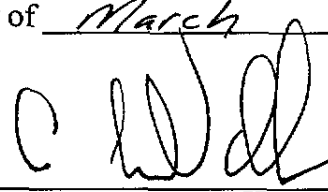

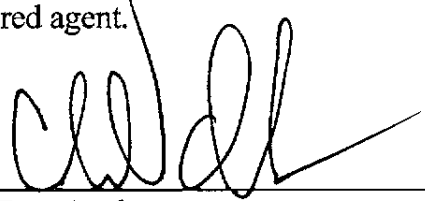
