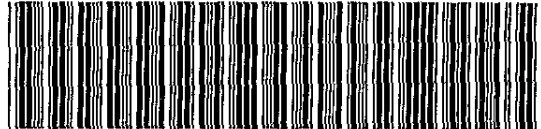

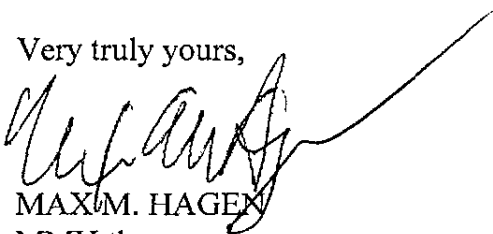

FIRST: Amendment(s) adopted and modifying articles:

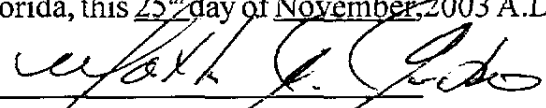
