**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF
SIGNET DIAGNOSTIC IMAGING SERVICES GROUP, LLC**

Pursuant to the provisions of Section 608.411, Florida Statutes, Signet Diagnostic Imaging Services Group, LLC, a Florida limited liability company, does hereby adopt the following amendment to its Articles of Organization:

FIRST: The Articles of Organization of Florida Signet Diagnostic Imaging Services Group, LLC were filed on March 13, 2003, and assigned Document Number L03000009264.

SECOND: Article I of the Articles of Organization is hereby amended to read as follows:
