ARTICLES OF ORGANIZATION FOR J&S HOLDINGS, LLC a Florida Limited Liability Company

The undesigned, an authorized representative of a Member, desiring to form a limited liability company under and pursuant to Florida Statute 608, entitled the Florida Limited Liability Company Act, does hereby adopt the following Articles of Organization for such company:

ARTICLE I - NAME
