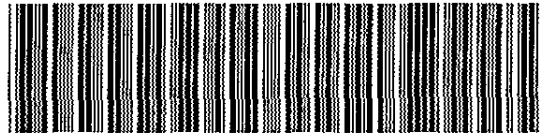

ARTICLE 5
CONTINUATION OF BUSINESS
