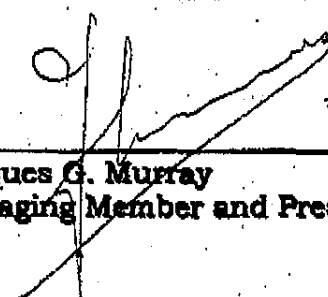
This article amends the Article of Organization of OBR DEVELOPMENT LLC, a Florida limited liability Company.
