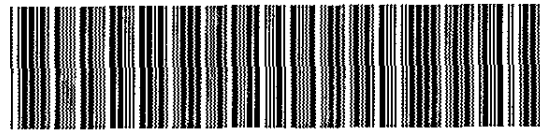

ARTICLES OF ORGANIZATION

OF

PETERSON & KOLKA PROPERTIES, L.L.C.

Article I. Name

The name of this limited liability company is Peterson & Kolka Properties, L.L.C. ("the Company").

Article II. Duration

The duration of the Company shall be perpetual.

Article III. Address of Principal Office


**CERTIFICATE OF DESIGNATION OF
