**ARTICLES OF ORGANIZATION
OF
INFINITE PRODUCTION, LLC**

The undersigned, being the Members and Organizers of the Limited Liability Company hereby being formed under the Chapter 608 of the Florida Statutes, do hereby adopt the following Articles of Organization for the Limited Liability Company:

**ARTICLE I
NAME**

The name of the Limited Liability Company is:

**ARTICLE II
PERIOD OF DURATION**

The Limited Liability Company shall continue until the occurrence of an event set forth in the Operating Agreement which causes the termination of the Limited Liability Company.

**ARTICLE III
PURPOSE**

The Limited Liability Company is organized to engage in and do any lawful act concerning any lawful business, other than banking and insurance, for which a limited liability company may be organized in accordance with the Chapter 608 of the Florida Statutes, including all powers and purposes now and hereafter permitted by law to a limited liability company.

REGISTERED AGENT**



ARTICLE V ADDRESS OF PLACE OF BUSINESS

The mailing address and principal office of the Limited Liability Company is 3795 Golden Point Drive, Aventura, Florida 33180.

ARTICLE VI MANAGEMENT

The existing Members shall have the right to admit additional Members to the Limited Liability Company, by the unanimous vote or consent of the Members.

**ARTICLE XI
CONTINUITY OF BUSINESS**

The remaining Members of the Limited Liability Company, by the unanimous vote or consent of the Members (other than the Member who caused the Withdrawal Event), may continue the Limited Liability Company upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Limited Liability Company.

**ARTICLE XII
MEMBER LIABILITY**

None of the Members of the Limited Liability Company are liable for payment of any debt, obligation or other liability of the Limited Liability Company.

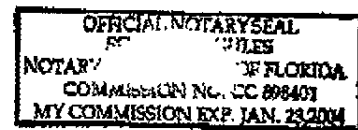

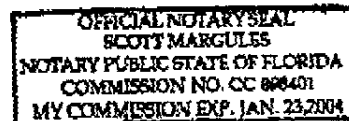
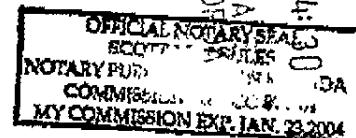
