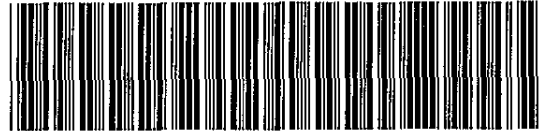

ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Act, F.S. Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company (the "Company") shall be NPI - COLUMBUS COURT, L.L.C.

ARTICLE II - DURATION

The limited liability company shall have perpetual duration.

ARTICLE III - PRINCIPAL PLACE OF BUSINESS AND ADDRESS

The principal place of business and the address of the Company shall be c/o FCA Corp., 5847 San Felipe, #850, Houston, TX 77057, and the mailing address is c/o FCA Corp., 5847 San Felipe, #850, Houston, TX 77057.

ARTICLE IV - PURPOSES AND POWERS

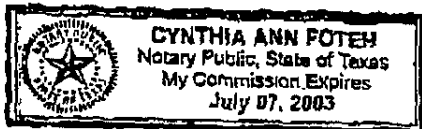
