**ARTICLES OF ORGANIZATION
OF

ARTICLE I - NAME

ARTICLE V - ADMISSION OF NEW MEMBERS

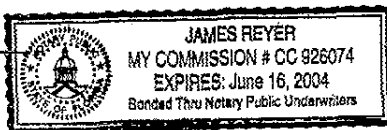
