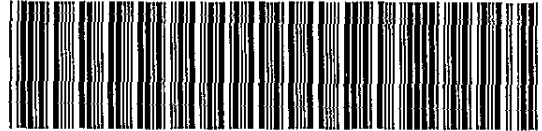

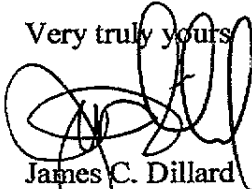

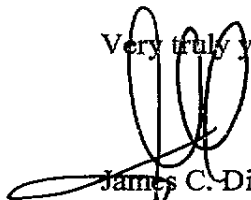

Pursuant to the provisions of Title XXXVI, Chapter 608 of the Florida Statutes

ARTICLE ONE

The name of the Limited Liability Company is Gregory A. Fortner, L.L.C.

ARTICLE TWO

The purpose or purposes for which the Limited Liability Company is formed are as follows:

To transmit, reproduce, exploit, exhibit, present, perform, and broadcast theatrical plays, dramas, operas, musical compositions, or scores, ballets, musical comedies, books, and all dramatic, musical, and motion picture productions and publications of every kind, both copyrighted and uncopyrighted, for public or private performance in any state or possession of the United States of America or any foreign state, country, or territory throughout the world, by radio, mechanical recording, television, and all scientific processes of a like or similar nature now in being or which shall hereafter be made in conjunction therewith, either with or without sound effects or talking contrivances therewith synchronized or other wise adapted or related thereto, and to lease, license, and grant rights, licenses, and privileges therein to other persons, firms, or corporations throughout the world; to manufacture, produce, adapt, prepare, buy, sell, distribute, license, and otherwise deal in any materials, articles, devices, processes, or things and in general to engage in any activity within the purposes for which a limited liability company may be formed under the Limited Liability Company Act of Florida.

ARTICLE THREE

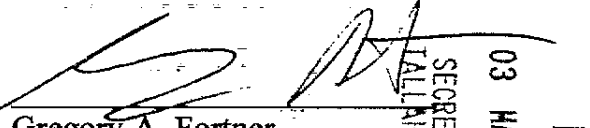
The duration of the Limited Liability Company shall be perpetual.

A manager shall discharge the duties of that position in good faith, and with that degree of diligence, care, and skill, which an ordinary prudent person would exercise under similar circumstances in a like position. In discharging the duties, a manager, when acting in good faith, may rely upon the opinion of counsel for the company, upon the report of an independent appraiser selected with reasonable care by the members, or upon financial statements of the company presented to the manager as correct by the members, or as stated in a written report by an independent public or certified public accountant or firm of accountants fairly to reflect the financial condition of the company.

ARTICLE SEVEN

The name and address of the managing member is Gregory A. Fortner at 13 Bedford Drive Palm Coast Florida 32137.

ARTICLE EIGHT

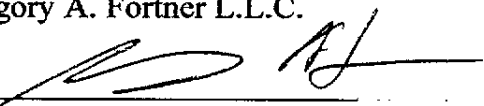
