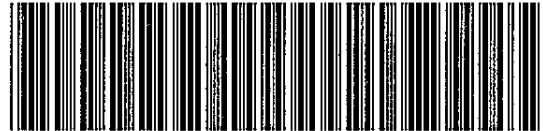

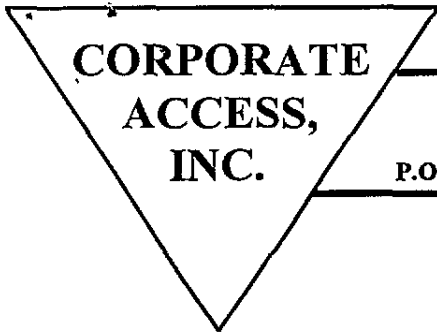


ARTICLE VIII. AMENDMENT


