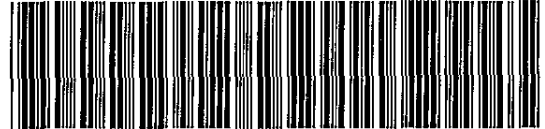

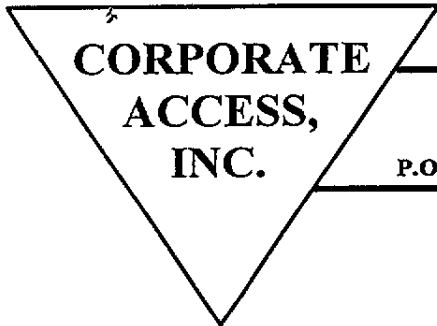

**THESE ARTICLES OF ORGANIZATION OF BROOKLINE ATLANTIC ST. 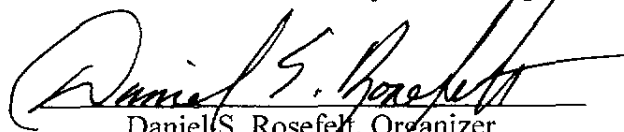
