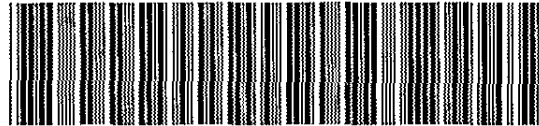





consent of all the remaining members, provided that is a least one remaining member.


