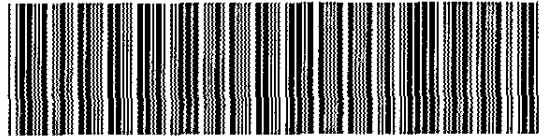

ARTICLES OF ORGANIZATION
OF
DOLLARMAX SUPER STORES, LLC.

The undersigned, desiring to form a limited liability company under the provisions of Florida Statute 608, as amended, hereby sets forth the following:

ARTICLE I
Name

The name of the Limited Liability Company is **DOLLARMAX SUPER STORES, LLC.** (hereinafter referred to as the "Limited Liability Company")

Principal Office & Mailing Address

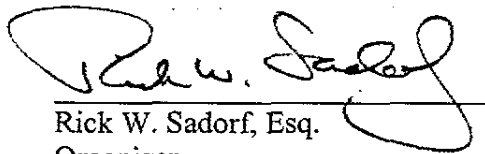

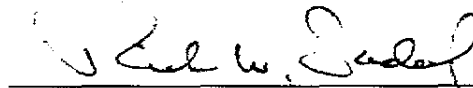
