These Second Articles of Amendment to the Articles of Organization of AEM ANDERUNG, LLC (the "Limited Liability Company") filed March 20, 2003, as amended by the Articles of Amendment filed May 29, 2003, are hereby amended as follows:

Article IV incorporated in the Articles of Amendment filed May 29, 2003 is hereby deleted and replaced in its entirety by the following Article IV:
