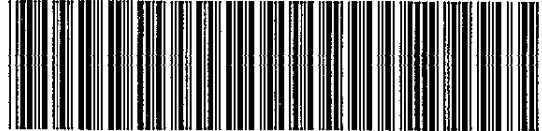

MANAGEMENT

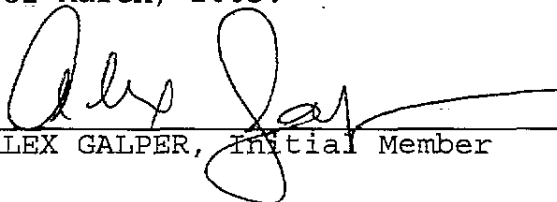
The management of the Company is reserved to the members of the Company in accordance with the Company's operating agreement.

RELATIONSHIP OF ARTICLES OF ORGANIZATION TO OPERATING AGREEMENT

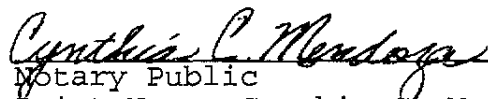
If a provision of these Articles of Organization differs from a provision of the Company's operating agreement, then, to the extent allowed by law, the operating agreement will govern.
