

ARTICLES OF ORGANIZATION OF: SYNERGY INDUSTRIAL ENTERPRISES, LLC

AMARIA CORD TAILS The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I -- NAME
