**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF ORGANIZATION  
OF

Pursuant to the provisions of Section 605.0202 of the Florida Revised Limited Liability Company Act, **SAVI INVESTMENTS, LLC** adopts the following Articles of Amendment to its Articles of Organization:

**FIRST:** The name of the limited liability company is **SAVI INVESTMENTS, LLC** (the "Company").

**SECOND:** The Articles of Organization of the Company were filed with the Florida Department of State on March 21, 2003, under Document Number L03000010265, and amended pursuant to the Articles of Amendment to Articles of Organization of the Company filed with the Florida Department of State on November 23, 2020.

**THIRD:** Article IV of the Company's Articles of Organization shall be amended and restated in its entirety as follows:
