ARTICLES OF ORGANIZATION SUNSOUTH TECHNOLOGY, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be SUNSOUTH TECHNOLOGY, LLC (the "company").

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the company shall be 109 South McGee Street, Bonifay, FL 32425.

ARTICLE III - DURATION

The company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The company-s existence shall be perpetual unless the company is earlier dissolved as provided in the operating agreement of the company.

ARTICLE IV - REGISTERED OFFICE AND AGENT

ARTICLE V - ADDITIONAL CAPITAL CONTRIBUTIONS

Each member shall make additional capital contributions to the company only upon the consent of the members owning a majority interest in the company.

No additional members shall be admitted to the company except as set forth in the operating agreement of the company. A member may transfer his or her interest in the company as set forth in the operating agreement of the company, but the transferee shall have no right to perticipate in the management of the business and affairs of the company or become a member unless the transfer compiles with the requirements set forth in the operating agreement.
