
**ARTICLES OF DISSOLUTION

Pursuant to the provisions of Section 608.441 of the Florida Limited Liability Company Act, KITSON & PARTNERS IV, LLC, a Florida limited liability company (the "Company"), hereby files the following Articles of Dissolution for the purpose of dissolving the Company:
