**ARTICLE IV - Duration:**

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The company's existence shall be perpetual unless the company is earlier dissolved as provided in these articles of organization.

**ARTICLE V - Capital Contributions:**

The members of the company shall contribute equally to the capital of the company the cash or property set forth as follows:

- a. William C. Zavistoski \$12,500.00 in materials and signs
- b. Elfriede E. Zavistoski \$12,500.00 in cash

**ARTICLE VI - Additional Capital Contributions:**

Each members shall make additional capital contributions to the company only on the unanimous consent of all members.

**ARTICLE VII - Admission of New Members:**

No additional members shall be admitted to the company except with the unanimous written consent of all the members of the company and on such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the company as set forth in the regulations of the company, but the transferee shall have no right to participate in the management of the business unless the other members of the company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.

**ARTICLE VIII - Termination of Existence:**

The company shall be dissolved on the death, insanity, bankruptcy, retirement, or dissolution of a member or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by the consent of all the remaining members, provided there are at least two remaining members.

**ARTICLE IX - Management:**
