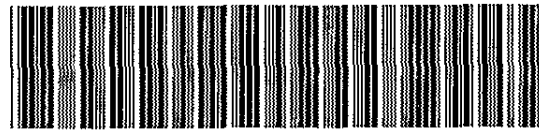

ARTICLES OF ORGANIZATION

OF

AMERICAN AMATEUR GOLF TOUR, LLC

The undersigned, desiring to form a limited liability company under the provisions of Florida Statute 608, as amended, hereby sets forth the following:

ARTICLE I

Name

The name of the Limited Liability Company is **AMERICAN AMATEUR GOLF TOUR, LLC**. (hereinafter referred to as the "Limited Liability Company")

ARTICLE II

Principal Office & Mailing Address

The principal place of business and mailing address of this Limited Liability Company shall be 5445 West Cypress Street, Suite 110, Tampa, FL 33607.

ARTICLE III

Duration





Written Operating Agreement

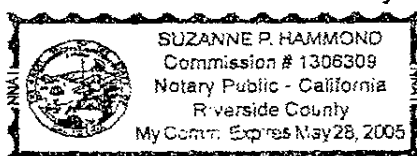
