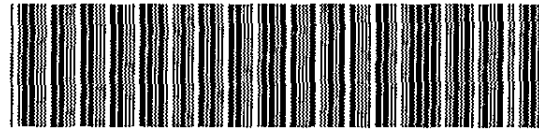

NAME AND PRINCIPAL PLACE OF BUSINESS
