ARTICLES OF ORGANIZATION

OF

BIRKHOLZ APPRAISAL SERVICE, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be **BIRKHOLZ APPRAISAL** SERVICE, L.L.C., ("Company"). The mailing address and street address of the Company in Florida shall be 930 5th Street West, Palmetto, Florida 34221.

ARTICLE II - DURATION
