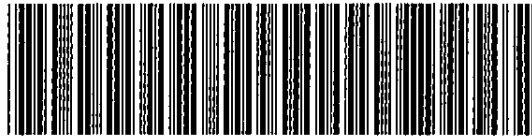

Knocklayd Investment, LLC**


- First:** The name of the company is **Knocklayd Investment, LLC**.
