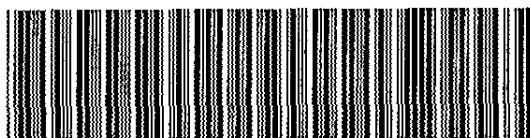




CERTIFICATE OF DESIGNATION OF
