The name of the Limited Liability Company is **ROSEN-AUKER DEVELOPMENTS, LLC**

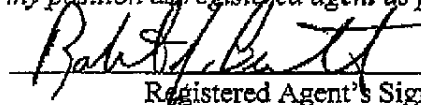
ARTICLE II - ADDRESS
