The name of the professional limited liability company shall be PEDIATRIC POTENTIALS OF FLORIDA, L.L.C. ("Company").

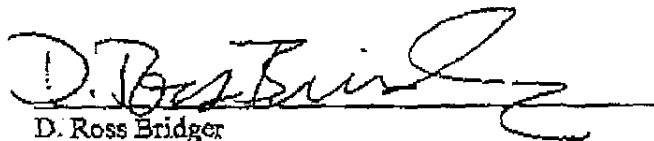
ARTICLE II - ADDRESS
