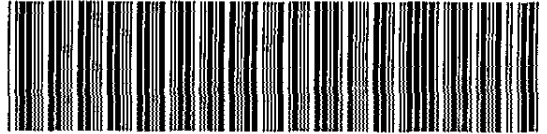

Pursuant to the provisions of § 608.441 of the Florida Limited Liability Company Act (the "FLLCA") and for the purpose of effecting the dissolution (the "Dissolution") of Stuart Commons, LLC, a Florida limited liability company (the "Company"), DOCUMENT NUMBER L03000010930 the Company has adopted these articles of dissolution (the "Articles of Dissolution").

1. Effective Date of Dissolution. The effective date of the dissolution of the Company is March 26, 2003.

2. Occurrence Resulting in Dissolution. The Articles of Organization of the Company were inadvertently filed with the Secretary of State on March 26, 2003, **and are a duplication of Articles of Organization filed with the Secretary of State on January 10, 2003 for Stuart Commons LLC., a Florida limited liability company, DOCUMENT NUMBER L03000001182.** The inadvertent filing of such Articles of Organization was not discovered until approximately July 7, 2003. The Company never had, and never will have, any members and, in accordance with the provisions of § 608.441 (1) (d) of the FLLCA, is dissolved.

3. No Liabilities. The Company does not have, and never had, any debts, obligations or liabilities of any kind.

4. No Property. The Company does not have, and never had, any property or assets.


5. Legal Proceedings. There are not suits pending, nor have there ever been any suit filed against, the Company.

6. Execution of Articles of Dissolution. The Articles of Dissolution comply with the requirements of the FLLCA and have been executed by Edward H. Gilbert, the same party that executed the Articles of Organization of the Company. Since the Company does not have, and will never have, any members, Edward H. Gilbert is the only party that can execute these Articles of Dissolution.
