ARTICLE I - Name

The name of this limited liability company shall be EQUALITY MARKETING, LLC.

ARTICLE II - Duration


ARTICLE X - Amendment

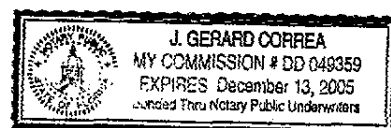
