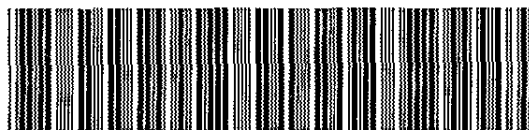

CONTINUATION OF BUSINESS


