OF

ADVANCED GERIATRIC & INTERNAL MEDICINE, P.L.

The undersigned, acting as organizer of this professional limited liability company pursuant to Chapters 608 and 621 of the Florida Statutes, hereby forms a professional limited liability company under the laws of the State of Florida and adopts the following Articles of Organization for such professional limited liability company:

ARTICLE I - NAME OF COMPANY

The name of the professional limited liability company is Advanced Geriatric Internal Medicine, P.L. (the "Company").

ARTICLE II - PRINCIPAL OFFICE

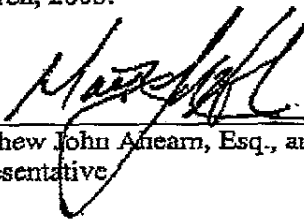
ARTICLE V - GENERAL NATURE OF BUSINESS

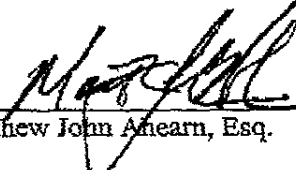
