**ARTICLES OF ORGANIZATION
OF

The undersigned, being authorized to execute and file these Articles on behalf of the members for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, do hereby certify and adopt these Articles of Organization.

ARTICLE I - NAME

ARTICLE X - AMENDMENT

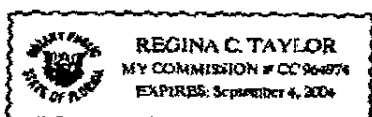
These Articles of Organization and the Regulations and Operating Agreement of the Company may be amended from time to time as prescribed by law.
