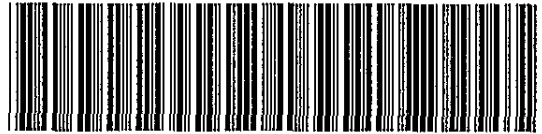

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

1. NAME. The name of this limited liability company is THOMAS & FRIEDLANDER, L.L.C., (Company).

2. DURATION. The Company shall exist from the date of filing these Articles of Duration with the Department of State until the occurrence of any of the events specified in Florida Statutes Section 608.411, unless continued by the unanimous consent of all of the remaining members.




