

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

ARTICLE I

NAME

The name of the Limited Liability Company is: DESTIN REEF CONSTRUCTION, LLC.

ARTICLE II

PRINCIPAL PLACE OF BUSINESS

The principal place of business of the Limited Liability Company is: 135 Durango Road, Destin, FL 32541.

ARTICLE III

REGISTERED OFFICE AND AGENT

The address of the initial registered office of the Limited Liability Company is: 4507 Furling Lane, Suite 210, Destin, Florida 32541. The name of the initial registered agent is Jeffrey M. Stephens.

ARTICLE IV

MANAGEMENT

MEMBERS

The initial Members of the Limited Liability Company are: Michael R. Collins and Bob Price.

ARTICLE VI

LIMITED LIABILITY

The members and managers of the Limited Liability Company shall have limited liability as provided for in the operating agreement and the applicable provisions of the Florida Limited Liability Act.

ARTICLE VII

INDEMNIFICATION


ARTICLE IX
