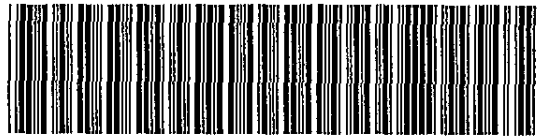

**ARTICLES OF ORGANIZATION OF
CWC, L.L.C.
a Florida Limited Liability Company**

The undersigned, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I

COMPANY NAME

The name of the limited liability company is **CWC, L.L.C.** (The "Company").

ARTICLE II

ADDRESS

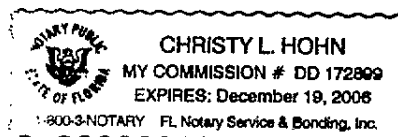
