ARTICLES OF ORGANIZATION

OF

BARDON, L.L.C.

The undersigned, for the purpose of forming a limited liability company, under the Florida Limited Liability Company Act, F. S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be BARDON, L.L.C. ("Company"). The Principal place of business and mailing address of the Company in Florida shall be 1701 West Garden Street, Pensacola, Florida 32501.
