ARTICLES OF ORGANIZATION

OF

Pursuant to the authority of Section 608.407 of the Florida Limited Liability Company Act, as amended from time to time, the following are adopted as the Articles of Organization of the limited liability company organized hereby: —

ARTICLE I

NAME

The name of the limited liability company (the "Company") shall be BRAY & GILLESPIE VIII, LLC.

The Company will be a member-managed company managed in accordance with and subject to the requirements of the Act and the Operating Agreement of the Company.




