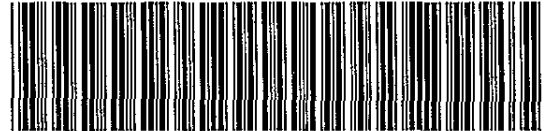


Company Management
