**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF
MGH MEDDESIGN, LC**

Pursuant to § 608.411, Florida Statutes, MGH MEDDESIGN, LC, a Florida Limited Liability Company (the "Company"), through the undersigned sole member of the Company, does hereby adopt the following Amendment to the Articles of Organization:

1. The Articles of Organization were filed on March 31, 2003 and assigned document number L03000011535.

2. On February 4, 2008, the sole member of the Company, Eduardo Gonzalez Hernandez (hereinafter "Sole Member"), approved the following amendment to Article I of the Company's Articles of Organization to effect a change in the Company's name.
