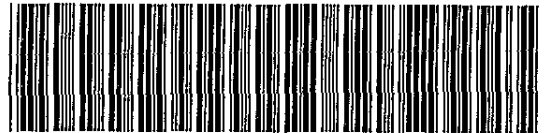



The mailing address and street address of the principal office of the Limited Liability Company is 440 West 11th Street, Panama City, Florida 32401.


