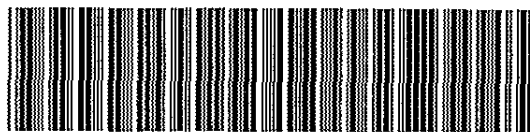

4. **Management.** The business of the Company shall be conducted under the exclusive management of one or more of its members.


